I. Call to Order/Introductions

II. ImageTrend Vault

- Demonstration
 - Acquire all our archive data (pre-2017), previously on Sansio product, now transitioned to NEMSIS
 - Last year, providers signed an agreement for the archive function
 - ImageTrend vault is now available with the archive section for providers to search old records
 - Demo how to search records by date range, agency name etc
 - Audit trail will document who is searching for what record
 - New url to access this: riversidecounty.imagetrendvault.com
- Gather login needs from provider
- Go over implementation plan for gaining access and usage
 - o Send Nick an email to request for access to the archive vault
 - o REMSA will keep a roster of who has access to the vault, does not tie to licensure

III. Identified Issues and System Updates

- Review of existing defects (Zoll)
 - o Zoll software development kit will be fixed in the next update coming Wednesday
 - Some invisible records with no "status"
 - Every vital sign should come in consistently now after the fix
 - Zoll will now support Bluetooth connectivity in poor satellite areas within the app to send info for case importing
- Review of NIFIRs apparatus tool to applicable
- Rationale behind "secured" status
 - Isolate and quarantine records with high degree/sensitivity to make the record secure, it will be shut off from providers, and only allow 1 superadmin to view it

• Once it is turned secure, it will not be viewable, not even through CQI or exports etc, only upon subpoena request

New requested Items

IV. Change Requests

- Added ability for Super Admins to control all transfer settings for receipt of agency transfers
 - Since Cat City and Morongo fire transfer amongst each other, they had a conflict in documenting transfer, with this in mind, it has now been updated where the providers can go in themselves to update it as needed
- Discuss adding validation rules to vitals for positioning and method
 - AMR brought up this issue with CQI, monitors import all vital signed, but the qualifiers for positioning were not recorded in detail
 - Need to add the validation rules to help the qualifiers pull over
 - o ePCR workgroup is good with Nick moving forward with this change
- Other request
 - Cat City requested to ass pulse ox symmetry qualifier, if we can add one for home o2, if patient
